One day seminar on "Scope of Patentability under the Patents Act" organized by Kamla Nehru College of Pharmacy, Butibori, Nagpur on September 11th, 2015. The seminar was organized for teachers and PG students.

In a two long sessions, Dr. Parimal P. Katolkar focuses on following points:

Patent system is a contract between the inventor and authority whereby the inventor gets exclusive rights for a period of 20 years in return for disclosing full details of the invention. A patent is a form of intellectual property. A patent gives its owner the right to exclude others from making, using, selling, and importing an invention for a limited period of time, usually twenty years. The patent rights are granted in exchange for an enabling public disclosure of the invention. An invention relating to a product or a process that is new, involving inventive step and capable of industrial application can be patented in India. However, it must not fall into the category of inventions that are non-patentable as provided under Section 3 and 4 of the (Indian) Patents Act, 1970. It is promotion of innovation—"useful Arts"—that is "the" stated purpose of patent law, at least as stated in the Constitution. But the Patent Act seeks to accomplish this goal by granting to the inventor a limited monopoly in exchange for disclosure. That is, patent law encourages disclosure of ideas by rewarding it.
